## 1 Introduction

This document change notice provides an overview of the changes to Euroclear Finland Tariff Release 2 which have been done since the first publication of the tariff in August 2016. The tariff was valid as of 7 May 2018.

In addition, some amendments in wordings, some typographical corrections and clarifications have been added to the tariff. These amendments are not described in this document.
